



## Meeting Minutes

### Big Dry Creek Watershed Association

1. **2020 Biological Monitoring Results:** Tami Schneck of Aquatics Associates provided a presentation summarizing findings of the Big Dry Creek biological monitoring conducted in October 2020. Findings included observations related to habitat conditions, macroinvertebrate sampling and fish shocking. Recommendations for continued monitoring in 2022 were also provided (see attached Powerpoint presentation).
2. **Big Dry Creek *E. coli* Source Identification Study:** Heather Otterstetter provided an update regarding on-going work to identify potential sources of *E. coli* at several locations between Standley Lake and I-25. In addition to HF183 sampling at outfalls, acetaminophen and caffeine were added at targeted locations as a tool to differentiate between treated/reclaimed wastewater and untreated sewage. As a result of the discussion at the meeting, a follow-up call was scheduled with Westminster staff and Wright Water Engineers to identify next steps in the investigation.
3. **Routine Business Items:**
  - a. Jane Clary requested articles for the year-end newsletter.
  - b. Shelley Stanley reported that the Woman Creek Reservoir Authority (WCRA) approved 2022 financial support of the Big Dry Creek Watershed Association and requested that Jane Clary provide a summary presentation on BDCWA's efforts to the WCRA Board in the spring of 2022.
  - c. Jane Clary noted that dues requests would be sent in early January 2022, as approved at the September 2021 Board meeting.
