# **Big Dry Creek Watershed Association Meeting**

**1. Introductions:** The meeting was attended by the Board and field and laboratory staff who are involved with the annual water quality monitoring program.

### 2. 2021 Water Quality Summary: Jane Clary, Wright Water Engineers

Jane Clary provided the Big Dry Creek Annual Water Quality Report for 2021. See attached Powerpoint for draft findings. The draft report will be provided to the Board later in April.

As a result of discussion at the meeting, additional special sampling locations will be added along the stream between bdc2.0 and bdc3.0 due to persistently elevated *E. coli* year-round at bdc3.0. Birds are suspected as a possible reason for elevated *E. coli* in the winter, but the additional sampling should help to better understand where the *E. coli* increases between bdc2.0 and bdc3.0 since dry weather outfall sampling did not identify a source in this reach. Details of the additional sampling will be developed following the meeting.

#### 3. Routine Business

- a. Update on Westminster *E. coli* study: Heather Otterstetter noted that the City of Westminster is working on some follow-up source identification work, including dyetesting a portion of the sanitary sewer on April 26, 2022.
- b. Focus areas for remainder of 2021:
  - i. Watershed Plan Update
  - ii. June: Considering a meeting outdoors on the creek with field and laboratory staff

iii. September: Board business meeting

iv. December: TBD

- c. Woman Creek Reservoir Authority: Jane will speak about the BDCWA annual report at the WCRA Board meeting.
